Executive summary

In March 2021, the European Union Agency for Criminal Justice Cooperation (Eurojust) and the European Union Intellectual Property Office (EUIPO) signed a 4-year service-level agreement aimed at strengthening cooperation in the area of intellectual property crime (IPC) and providing a more robust response against intellectual property (IP) infringements at the EU level.

As part of this agreement, Eurojust began the implementation of the IPC project, a novel initiative aiming at enhancing the judicial response against counterfeiting and piracy – by supporting EU Member States with complex cross-border IPC investigations – and contributing to the work of the EUIPO in the area of IP infringements. To that end, the project focuses on building, promoting and exchanging knowledge, tools and expertise, as well as on raising awareness.

This catalogue is one of Eurojust's deliverables, developed by the IPC project, and contains a collection of the judicial libraries of the 27 EU Member States and 13 affiliated Third Countries. This catalogue is an important resource that provides practitioners and legal experts with quick reference to national case-law and relevant legal documents across EU and international legislations.

Each page is dedicated to a Member State or an affiliated Third Country. Countries are ordered in accordance with Eurojust's protocol order – a method of listing Member States by alphabetical order based on their names in their official languages. Access to the judicial libraries is provided through hyperlinks, which can be accessed by clicking on the web address provided on the page. The libraries can also be accessed by scanning the QR codes with a smartphone camera.

Besides providing access to the national judgments, each country page outlines a selection of national courts whose rulings can be accessed through the judicial library provided. The list of courts mentioned is not exhaustive, therefore, we always recommend that a judicial library be consulted even if a specific court is not referred to.

The number and availability of judicial libraries differs across countries. In some countries, all of the available court decisions can be found in a single library. In others, the court rulings and other relevant documents are accessed through various online databases. In some cases, the availability of court decisions may be limited by date or by court hierarchy. Lastly, some judicial libraries are managed by private companies, therefore their content may only be available following the payment of a subscription fee.

The catalogue is updated on a yearly basis to maintain an up-to-date list of existing judicial libraries in the countries covered. We hope this catalogue will prove useful in your daily work and assist you in accessing important judicial decisions in your own or other countries.
