■ Network of National Experts on JITs

The JITs Network consist of experts, appointed by each EU Member State, representing judicial and law enforcement dimensions of a JIT. At a national level, the experts act as contact points whom practitioners can address with JIT-related questions. A list of contact points is accessible through the JITs Restricted Area or via available domestic channels.

This document provides guidance to practitioners on setting up a JIT with a third country. It presents the relevant legal bases, specific factors to consider, best practices, and a checklist for practitioners available also as a stand-alone document in all EU languages.

JIT MODEL AGREEMENT



The model agreement is routinely used when setting up a JIT, offering a common baseline for drafting a JIT agreement that practitioners can tailor to the specific needs of their case. It is available in all official EU languages and editable formats.

This product aims at presenting the ways in which the International Criminal Court – Office of the Prosecutor may be involved in JITs, the benefits of their involvement, and the support that Eurojust and the JITs Network Secretariat may offer in these specific situations.

The factsheet provides a comprehensive introduction of the JIT as a key tool for international cooperation, including information on the ways in which Eurojust supports JITs.

It is good practice to conduct an evaluation of the JIT after its closure. JIT practitioners may complete this form to conduct the evaluation in a logical and consistent way and to facilitate the gathering and sharing of information on JITs, best practices identified, and lessons learned.



JIT EVALUATION REPORTS



The JITs Network Secretariat reviews and processes the information gathered from JIT evaluations and produces JITs Evaluation Reports presenting the main findinds. Each evaluation report introduces a specific topic. The fourth JITs Evaluation Report focuses on multilateral JITs and includes a checklist for practitioners, which is also available as a stand-alone document in all EU languages.

Providing guidance on the composition, activities, and cooperation with external partners and third countries, these guidelines offer a clear and detailed framework for the work and tasks of the Network of National Experts on JITs.

JIT FUNDING PROCESS INFOGRAPHIC




